## Minor Participant's Waiver and Release of Liability

**2016 IMPORTANT: PARENT/GUARDIAN PLEASE READ AND SIGN BELOW**

*THIS IS A RELEASE OF LEGAL RIGHTS — READ AND UNDERSTAND BEFORE SIGNING*

IN CONSIDERATION OF \_\_\_\_\_, my child/ward, being allowed to participate in any way in the **BUILDING PEACEFUL FAMILIES / RED POWER DIVAS** training program and related events and activities ("The Program"), I the undersigned acknowledge, appreciate, and agree that:

The risk of injury to my child from the activities involved in The Program is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

1) FOR MYSELF, CHILD'S OTHER PARENT, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation; and,

2) I willingly agree to comply with The Program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in The Program itself, I will remove my child from the participation and immediately bring such attention to the nearest official; and,

3) I, for myself, child's other parent, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY WAIVE, RELEASE AND FOREVER DISCHARGE AND HOLD HARMLESS **BUILDING PEACEFUL FAMILIES / RED POWER DIVAS**, its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property due to my child's involvement or participation in The Program, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

4) I, for myself, child's other parent, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.
